

## DMS Usage Report – October 2014

### Summary of Monthly Operations

In the month of October, there were 37,056 messages posted with 10,665 DMS activations for 1,457 events. The DMS efficiency was 99.79% (1,454 of the 1,457 signable events had DMS messages posted). There was an average of 7.32 DMSs activated per each signable event and an average of 3.47 DMS messages were posted per each DMS activation. This resulted in an average of 25.43 DMS messages being posted per each signable event.

*Notes: DMS messages not associated with an event are not included because the SunGuide Software requirement to associate a message does not function properly at this time.*

### Summary of Average Monthly Operations
