

## DMS Usage Report – July 2015

### Summary of Monthly Operations

In the month of July, there were 36,320 messages posted with 9,029 DMS activations for 1,372 events. The DMS efficiency was 100% (1,372 of the 1,372 signable events had DMS messages posted). There was an average of 6.58 DMSs activated per each signable event and an average of 4.02 DMS messages were posted per each DMS activation. This resulted in an average of 26.47 DMS messages being posted per each signable event.

*Notes: DMS messages not associated with an event are not included because the SunGuide Software requirement to associate a message does not function properly at this time.*

### Summary of Average Monthly Operations

## DMS Messages by Time of Day
