Milestones:


- Transitioned Road Ranger operations to new vendor on Sunday June 30th at 9 PM.

- Coordinated with Project Managers and CEI for various roadway construction-related closures: EL Phase 2, I-395 / POMT, SR 826 / SR 836 Section 5, I-95 ramp to FL Turnpike / SR 826 West milling and resurfacing, and I-95 on-ramp resurfacing.
- Finalized 2013 SunGuide TMC Hurricane Response Action Plan (HRAP) Update.
- Presented to California's Regional Metropolitan Planning Organization about 95 Express Public Information.



Two additional DMS along the SR 826 Section 5 project became operational and are still under warranty. System availability is not measured for these devices.


