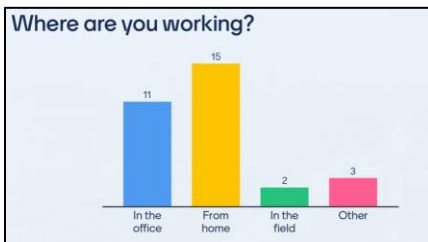
1. Purpose of Meeting

This meeting serves as a platform for TIM partnering agencies to highlight and discuss on-going initiatives, activities or events that are affecting or set to affect the surface transportation system of the southeastern Florida area. The meeting provides partners with an opportunity to voice concerns and raise questions regarding department related projects and incident management.

2. TIM Agency Updates

2.1 - FDOT District Six TIM Update

District Six SunGuide TMC Manager Alex Mirones welcomed everyone to the first virtual Semi-Annual Miami-Dade/Broward County Traffic Incident Management (TIM) Team Meeting. He provided the purpose of the meeting and the agenda items regarding updates presented from our TIM partners. Don said that a different interface will be tried to allow more interaction during these meetings. He presented several questions for attendees to get accustomed to the interface.



Alex provided District Six TIM updates pertaining to Transportation Management Center. He discussed the impact of the COVID-19 pandemic on events managed by the SunGuide TMC. Alex spoke about the TMC's resiliency with maintaining the Hurricane Response Action Plan and developing the Pandemic Action Response Plan (PRAP). The PRAP was created to ensure safety and continuous operation at the TMC.

District Six SunGuide TMC Project Manager, Donald Avery provided updates pertaining to the recent Palmetto Express configuration changes and improvements that were completed in the northbound direction and will begin in the southbound direction.

District Six SunGuide TMC Incident Management Coordinator, Rulx Belizaire presented additional updates regarding the TMC, RISC Program, Road Rangers, Incident Response Vehicle fleet, TIM Teams. The TMC is evaluating a connected vehicle technology pilot project for the Incident Response Vehicle (IRV) program. This project entails GPS devices that are mounted on the arrow boards of IRV trucks. When an arrow board is raised, a signal is sent resulting in a hazard notification on navigation apps. Rulx also discussed the historical upward trend of RISC incidents.

For TIM Team updates, District Six now has additional TIM Team meetings specific to the western region (Palmetto Corridor) and eastern region (95 Corridor) of Miami-Dade County. These meetings are designed to address incident management, coordination, and specific issues that are unique to the respective region. Rulx discussed the TIM Team webpage. He demonstrated the interactive Traffic Incident Management dashboard and the Responder's Site. The Responder's Site allows users to see up to four traffic cameras. This site also provides a summary of active traffic events and links to a camera to view an incident. Those interested can request access from the sunguide.info TIM page.

Don followed up with some additional survey questions for attendees.



2.2 - FDOT District Four TIM Update

District Four Traffic Incident Management Coordinator Timothy Stanberry presented. He provided an overview of managed events comparing 2019 and 2020, their TIM updates pertaining to upcoming TIM trainings, the RISC Program, and updates regarding SIRV and Road Rangers. Tim highlighted that the SIRV Operators provided assistance to the City of Hollywood Police Department at a COVID-19 Food Bank whenever they were not assisting traffic incidents or RISC events.

2.3 - Florida's Turnpike TIM Updates

Florida's Turnpike Enterprise Traffic Incident Management Coordinator Michael Washburn presented. He began the presentation with raising awareness to the National Traffic Incident Response Awareness Week from November 9th until November 15th, as well as the outreach initiatives planned for the week. Mike provided statistical data with supporting analysis regarding traffic volume trends, TMC SunGuide events worked, their STARR program, and the RISC program.

2.4 - Miami-Dade Expressway Authority (MDX)

MDX TMC Manager Gerardo (Jerry) Cosme presented TIM updates for MDX. He provided SunGuide statistics, Road Ranger statistics, construction updates, and RISC program updates. Jerry spoke on MDX TMC's ability to continue operations despite the impact of the COVID-19 pandemic. He provided an overview of MDX TMC's managed events and Road Rangers events stating there was a minimum of 15 percent decrease. Jerry also shared the improvements completed for multiple construction projects including Project #83628, which reinforced inner shoulder along SR 836 designating access for Express Bus service from the Dolphin Station Park and Ride to Downtown Miami.

2.5 - PortMiami Tunnel

The PortMiami Tunnel TMC Manager Luis Enrich presented their TIM updates. He provided TMC statistics such as the total managed incidents, traffic data per year, a performance summary per year, and a video of incidents that occurred within the tunnel.

3. Construction Updates

3.1 – I-395/SR 836/I-95 Design Build Project

Senior Community Outreach Specialist Oscar Gonzalez presented construction updates for the I-395/SR 836/I-95 Design-Build Project. He provided the recent construction activities including ongoing nighttime closures on I-95 from NW 8 Street to NW 29 Street for concrete replacement on the northbound lanes. Oscar also provided the status of the project's auger cast pile foundations and bridge columns in addition to other pertinent details to the project.

3.2 – Golden Glades Multimodal Transportation Facility (GGMTF)

Community Outreach Specialist Sandra Bello presented construction updates for the GGMTF. Phase one of the project is complete, which included the temporary closure and relocation of the Incident Response Area and Bus Terminal from the East Lot to the West Lot. The project is currently in phase two which includes building the parking garage, a kiss and ride platform, and other structures. Sandra highlighted that the project is on track to finish ahead of schedule.
